# IMMUNIZATION REQUIREMENTS FOR DENTAL STUDENTS

### **General Information:**

- The University of Saskatchewan requires that all students attending a Health Science College provide documented proof of immunization.
- Completion of these requirements is mandatory and are not subject to accommodations for philosophical reasons.
- Completion of the immunization requirements is the responsibility of the student. Most immunizations are covered by your provincial health card.
- CONSENT: Immunization records and/or serology results will be shared with your College and clinical placements throughout your studies as required – this is to ensure your safety and the safety of your clients. You are required to sign a consent form to authorize sharing of this information.

## **IMMUNIZATION INSTRUCTIONS**

- 1. Review your immunization requirements (see next page).
- 2. Locate your childhood and adult immunization records. If your records are not in English please have them translated prior to submitting. If you do not have these records, contact your Public Health Unit or Family Doctor. If you are in the Saskatoon Health Authority, call the Record Line at 306-655-4090. There is a \$25.00 charge to get your records. If you are outside of the Saskatoon Health Authority, contact your Home Public Health region.
- 3. You may choose to see your Family Physician to begin and/or complete your immunization review, but you are still required to have one appointment with Student Health Services to ensure all requirements have been met.
- 4. Email a PDF copy of your immunization records, a PDF copy of any blood tests that were done to confirm immunity, and the attached, signed consent PDF form to student.wellness@usask.ca. The Student Wellness Centre must receive this information before you are eligible to be booked for an immunization review. We recommend that you send all the required immunization documentation within 2 weeks of receiving this letter
- 5. To do your immunization review, call the number at the top of the page and ask to book a 30 minute appointment to see the nurse. Please book an appointment ASAP.
- 6. Failure to complete as much as possible of your Immunizations by Sept 30, 2025 will mean you will not be able to participate in any clinic experience. All immunizations must be completed by May 30, 2026 or you will be held back from doing clinical experience in second year.

# **Specific Immunization Requirements**

# **College of Dentistry**

### Tetanus/Diphtheria (Td ):

Primary series of 3-5 doses, then a booster every 10 years

#### Pertussis:

 Primary series and adults are encouraged to have a Td booster with the pertussis component once in their adult lifetime. Some colleges mandate this

### Polio:

Primary series, booster if travelling in endemic areas

#### Measles, mumps, rubella:

 Documented proof of vaccination with 2 doses of measles, mumps and rubella OR proof of immunity by serological evidence (please attach).

### **Hepatitis B:**

- A series of two or three doses followed by an antibody check.
- If you have already received the series, lab evidence of immunity is required (please attach)
- As well, a Hepatitis B surface antigen test must be done. If the antigen test is positive, consult your Health Care Provider. Refer to your specific College Policy for guidelines regarding clinical practice.

## Varicella (Chickenpox)

 Serological evidence of immunity (please attach) OR proof of two doses of varicella vaccination

#### Influenza

Required annually
